The Airline Business segment is responsible scheduled passenger and charter traffic as well as cargo sales, customer service and service concepts, flights operations and activity connected with the procurement and financing of aircraft. The Aviation Services segment comprises aircraft maintenance services, ground handling and the Company's catering operations as well as real-estate management and facility services for its operational premises. The Travel Services segment consists of the Company's domestic and foreign travel agency operations, as well as tour operations and the operations of the reservations systems supplier, Amadeus Finland Oy.

Fiskars Oyj Abp is a Finland-based supplier of consumer goods for the home, garden and outdoors. The Company reports four segments: Europe, Middle East and Asia-Pacific (EMEA) and Americas, which manage the Home, Garden and Outdoor business areas, as well as Wartsila, an associated company, and Other, which includes the Company's real estate activities. Its international brand portfolio comprises Fiskars, which offers scissors, utensils and garden tools; Iittala, which is a Scandinavian design brand, and Gerber, which offers personal, outdoor, tactical and industrial gear. Its regional brands comprise Arabia Finland, a Finnish designer; Royal Copenhagen, which offers hand-painted porcelain; Rörstrand, a Swedish craftsman; Hackman, which offers cookware and cutlery; Leborgne, a French producer of construction tools; Ebertsankey, which offers gardening products, and Buster, a producer of aluminum boats. In October 2013, the Company's brand Iittala entered Chinese and Italian markets.

Frisq Holding AB (publ) is a Sweden-based company, which is primarily focused on the healthcare industry. The Company operates as a provider of mobile application for monitoring health related information. The Company's mobile application includes general recipe database and allows to manage and order prescriptions.

Global Bioenergies SA is a France-based company that specialises in the development of a process to produce isobutene biologically from renewable resources. Isobutene, a hydrocarbon, can be converted into fuels such as isooctane, as well as into various materials (synthetic, rubber, organic glass, plastics). The process developed by Global Bioenergies SA is based on the design of an artificial metabolic pathway comprising several enzymes catalysing reactions not observed in nature. Six patent applications have been filed by the Company. The first two applications covering the key steps of the bio-production of isobutene and other olefins have already been published.

Hemostemix Inc is a Canada-based clinical-stage biotechnology company. The Company's principal business is to develop, manufacture and commercialize blood-derived cell therapies for medical conditions, including critical limb ischemia (CLI). The Company's clinical-stage candidate, ACP-01, is an autologous cell therapy for the treatment of CLI. ACP-01 is in a Phase II clinical trial in Canada, South Africa and the United States. The Company also focuses on developing other cell products, such as bone cell precursors (BCPs), myocardial cell precursors (MCPs) and neural cell precursors (NCPs). It operates in Canada and Israel. The Company has approximately 2,200 square foot research and manufacturing facility in Ness Ziona, Israel. Hemostemix Limited is the subsidiary of the Company.

Immunicum AB is a Sweden-based company principally engaged in the biopharmaceutical sector. The Company develops immunotherapy for therapeutic treatment of cancer and infectious diseases. The Company uses therapeutic vaccines to treat an already existing disease and is thus given to the already sick patients; therapeutic cancer vaccines administered to patients in order to delay or stop tumor cell growth, shrink tumors, prevent relapse, or to kill cancer cells.
